PACTUM SUMMER SCHOOL SCIENTIFIC COMMITTEE

Note: * USFAX suggests a possible distribution among students in terms of levels ** UKAIROUAN already suggests two teaching sessions: 1. Constitutional deadlock in transitions, 2. The political elites of transitions.

3. Teaching sessions

As agreed in our previous meeting, each summer school will have 5 teaching sessions (2 local Tunisians, 3 Europeans on line)

Tunisian partners will define within late July the nature of the teaching sessions for each venue and will communicate them to UMON and USIENA with the information

European partners (USIENA, UGRA, UMON, UNIMED) will convene in the coming days to coordinate their contribution for the teaching sessions.

4. Recruitment strategy

Applicants will be asked a curriculum vitae (in English of French) and to fill in an application form (to be circulated) asking (i) student identity, (ii) current university, level, discipline, (iii) other relevant activities (professional, associations...), (iv) certification of language proficiency in English and French, (v) information about student reasons for applying.

For this session, it is accepted that PhD candidates can apply with possible accreditation from doctoral schools to foster participation. However, undergraduate students should remain the key target.

On the basis of those elements, applications will be evaluated by each Tunisian hosting institution which will select a number of students (tentatively between 5 to 20, with extra participants on line). **Final results will be sent to UMON by September 10**th, **2021 at the latest**. The scientific committee will possibly reconvene in the week of September 13th to validate.

5. Logistics.

Each venue is free to organize as it best suits considering the context of Covid-19. Each will be responsible for hosting (hopefully) some students physically and to make on line participation available (with the assistance of USIENA if need be).

USIENA and UKAIROUAN will be in charge of spreading the information about the summer schools.

6. Sum-up of tasks ahead

- → All Tunisian partners must fill in the table sent by USIENA (reproduced) p. 1 and send by email to USIENA / UMON before July 27th.
- → All Tunisian partners but UKAIROUAN should send to USIENA / UMON the topic of the two teaching sessions and the names of their instructors before July 27th.
- \rightarrow European partners will convene to define their teaching sessions and instructors before July 27th and send them to USIENA / UMON.
- → Tunisian partners will evaluate applications from late July to early September, with final decision communicated on September 10th, 2021.
- → Scientific committee will re-convene in September. The possibility of a further meeting in Rome, Italy will be explore
